Dear Chairman Royce and Ranking Member Engel:

We, the undersigned organizations, are writing to express our strong support for H.R. 500 as introduced by Representative Honda (D-CA), Representative Bass (D-CA), Representative Poe (R-TX), and Representative Davis (R-III). H.R. 500 is a bi-partisan legislation that seeks to establish a survivor-led U.S. Advisory Council on Human Trafficking (Council) to review federal government policy on human trafficking. We urge you to co-sponsor and pass H.R. 500, a vital piece of legislation needed to establish this critical survivor-led Council.

Almost 14 years after the passage of the Victims of Trafficking and Violence Protection Act of 2000, there is now a substantial group of identified survivors of human trafficking who are willing and capable of informing policy, shaping programmatic and funding decisions, providing training and technical assistance, and leading educational efforts. Their voices need to be prioritized. As awareness of human trafficking grows, many groups, including concerned citizens, non-profit organizations, and government agencies, are stepping up to address this atrocity. Central to their success is the input of survivors, who have the most direct and intimate knowledge of the harm caused by trafficking and how any contemplated efforts at redress are likely to be received by those in a similar situations.

This legislation would establish an advisory council to provide advice and recommendations to the Senior Policy Operating Group (SPOG) and the President's Task Force to Monitor and Combat Trafficking in Persons. Specifically, H.R. 500 directs the Council to: (1) meet at least annually or at the request of the SPOG to review federal government policy and programs intended to combat human trafficking; (2) formulate assessments and recommendations to ensure that U.S. policy and programming efforts conform to best practices in the field of human trafficking prevention; (3) meet with the SPOG at least annually to formally present the Council's findings and recommendations; and (4) submit annual reports to the Task Force and other relevant congressional committees and agency heads.

This Council will provide a formal mechanism for senior administration and agency representatives seeking survivor input. Survivors will also have a designated and centralized place to provide their feedback. The Council is essential because it values survivors beyond their story. Moreover, survivor input on government priorities and actions will improve the likelihood that proposed plans and solutions are effective. We urge you to support this critical legislation now.
